

### DIGITAL COLLABORATION BETWEEN ESTONIA AND THE WORLD HEALTH ORGANISATION


- + The first pilot will be a **digitally verifiable international vaccination certificate ("Smart Vaccination Certificate")**, which could potentially support the effective implementation of the Covid-19 vaccination program.
- The technical leader of the project is Guardtime, an Estonian-born cybersecurity company leveraging the EU eIDAS-accredited trust service KSI Blockchain in its solution for tamperproof digital certificates.

### **GETTING VACCINATED. GETTING CERTIFICATE** Harry receives a vaccination from Nurse Hermione and he receives a certification of that vaccination It can be on paper with a scannable QR code or as an application on Harru's smart phone PII SHARING Needed



### **REPORTING ADVERSE EVENTS** Unfortunately, Harry feels ill after receiving the vaccination. He goes to the nearest hospital and provides Doctor Luna with his vaccine certificate. She prepopulates the Adverse Event reporting form with data scanned from Harry's vaccination certificate PII SHARING Needed



**SUPPLY CHAIN INTERGRITY** The vaccination certificate Harry was issued also contains information that overlaps with



supply chain data
